

Head Start/Early Head Start ANNUAL REPORT FOR FY 22-23

In FY 2022-2023, our Head Start/Early Head Start program served a total of 84 at-risk families. At any given time, 40 children (3-5 year olds) were enrolled in the Head Start Program and 36 children (0-3 year olds) were enrolled in Early Head Start. We are the program in Teton County that serves our community's most at-risk families, many of whom are Latino. We provide a full range of education, health, and parenting services to support these families and prepare their children for kindergarten.

We were fully enrolled this year. Attendance numbers were strong and child outcomes and parent involvement improved again this year. Even though our Head Start program faced staffing challenges this year, (a continuing, community-wide issue) we were able to hire two new qualified Head Start teachers who have been great additions to our team. This year we continued staff

retention programs to support the wellness and mental health of our teachers and offered wellness programs to Head Start/Early Head Start parents. CLC, in cooperation with our community partners, celebrated our 22nd year as the leading resource and often a lifeline for Teton County's most at-risk families and for our Latino community.

Based on Census data regarding poverty rates and local school district data regarding homelessness in Teton County, CLC estimates that 12% of children 0-5 years old are eligible for Head Start services.

This represents 115 children. Out of that 115 children, we served 84 (73%) in FY 22-23.


We have audited the financial statements of the Children's Learning Center, Inc. (CLC) (a nonprofit organization), which comprise the statements of financial position as of June 30, 2023 and 2022 and the related statements of activities, functional expenses, and cash flows for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of CLC as of June 30, 2023 and 2022 and the changes in its net assets and its cash flows for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Federal Review Results from 1/3/2022-1/7/2022, the Administration for Children and Families (ACF) conducted a Focus Area One Monitoring Review of the Children's Learning Center Head Start and Early Head Start programs. Based on the information gathered during this review, your Head Start program was found to have met the requirements of all applicable Head Start Performance Standards, laws, regulations and policy requirements with one exception in the area of "teacher qualifications." One Head Start teacher did not have all required teaching credentials at the time of hire but has a professional education plan for obtaining the qualifications within the identified timeline.
